SHIC SCHEDULE OF BENEFITS: EFFECTIVE 1ST JUNE, 2017

Coralisle Medical Insurance Company Ltd. will pay the benefits set forth in this Schedule at the percentage payable of the Standard Health Insurance Fees of the Cayman Islands/Reasonable and Customary (R&C) rate. Once the co-insurance requirement has been met, benefits are payable at 100% of the allowable charge for the remainder of the calendar year unless otherwise stated.

Please note this Schedule of Benefits is a guide only. Please refer to the policy contract with your Employer for full Terms and Conditions. All funds stated are in US Dollars.

Overseas Coverage for all Inpatient/Outpatient services is only available if the patient has been referred off island and a registered medical practitioner has provided written confirmation that the treatment is medically necessary and cannot be provided at a health care facility in the Cayman Islands. The pre-certification and pre-approval requirements outlined below must also be met.

•Diagnostic, MRIs, CT scans, vaginal ultrasounds, obstetrical ultrasounds exceeding 2 per pregnancy

•All Inpatient and Outpatient chemotherapy and radiation services

•Laboratory tests over \$300 for on island only

If pre-certification is not obtained the benefits will be reduced by 50%.

Pre-Existing Limitations: 10 month waiting period for all pre-existing conditions (unless portability applies).
